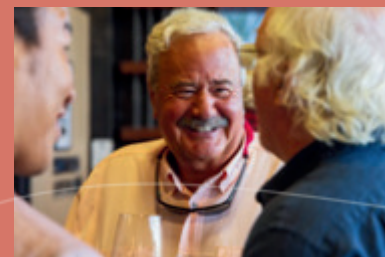

donor benefits FAQs

How do you calculate my benefits level?

Your benefits are calculated based on your total giving over the last 12 months.

Do event tickets and housing donations count toward my benefits level?

Yes. GTMF aggregates all your gifts for the purpose of calculating your benefits. For example, if you make a \$6,000 annual fund gift and buy two Salon Dinner tickets for \$4,000, you're eligible for benefits at the \$10,000 level.

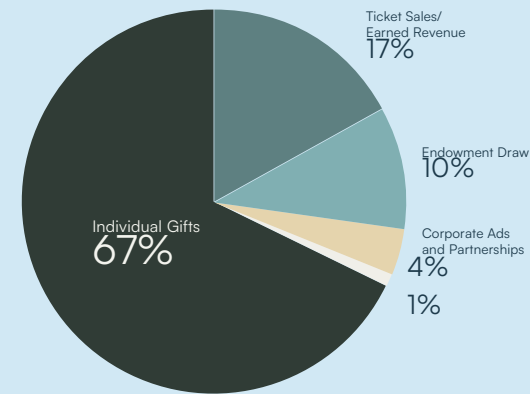
How long do I have access to benefits?

Your benefits are good for one year from the time you give. That means if you give at year-end, you'll have access to benefits like recognition in the program book donor list, event invitations, sponsorships, and more during the following summer.

Do benefits impact the deductibility of my gift? Yes. Certain benefits, such as the Guarantor Party and post-concert receptions, include non-deductible goods and services. You'll find the value of all non-deductible goods and services associated with your benefits on the official gift acknowledgements you receive from GTMF each year. Talk to your tax advisor to learn more about the impact of your GTMF benefits on the deductibility of your gift. Should you wish, you can decline benefits, allowing you to claim the full value of your gift for tax purposes. Members who decline benefits are still eligible for recognition in the Festival program book, sponsorships, and opportunities to meet artists in person.

I give through a Donor Advised Fund, Foundation, or my IRA. Can I still enjoy any donor benefits? GTMF cannot provide goods and services in exchange for grants from Donor Advised Funds, Foundations, or Qualified Charitable Distributions from IRAs. But there are many benefits you may be able to enjoy that don't include non-deductible goods and services. Recognition in the Festival program book, sponsor recognition, and opportunities to meet artists in person are good examples. Your tax advisor is the best person to consult to determine whether you can enjoy certain benefits.
